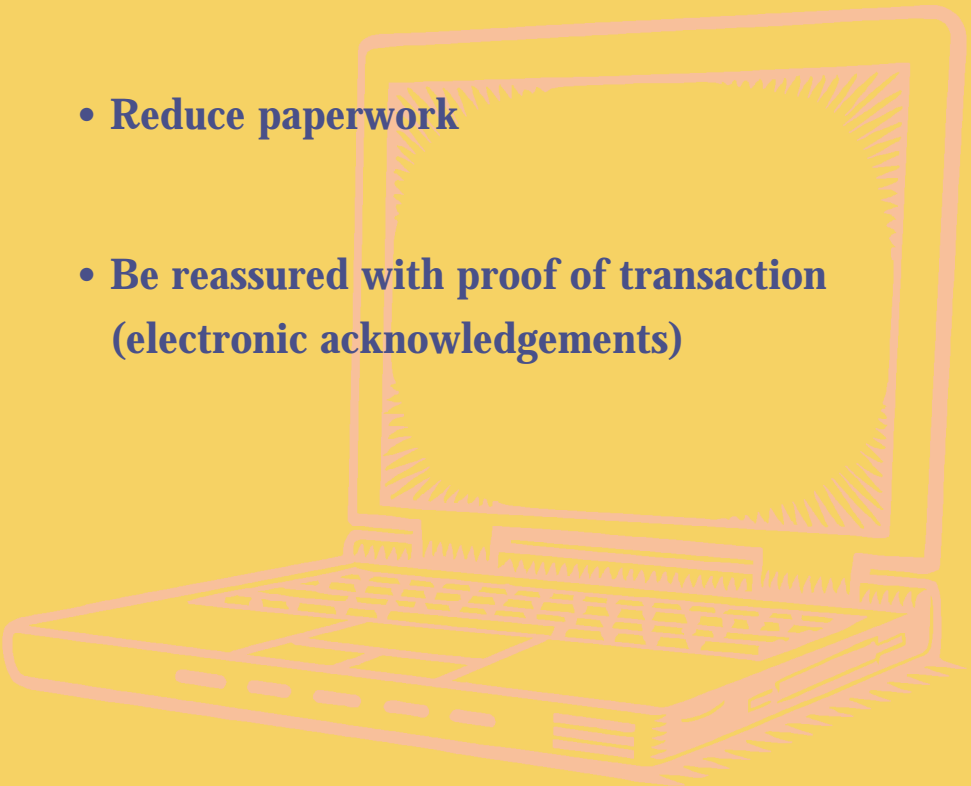

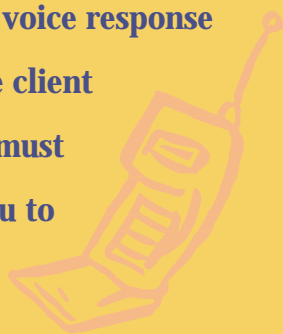
**Contact your software providers. Tell them what would make your job easier in terms of integrating accounting, return preparation, electronic filing and electronic payment. They need your input.**

# File **and** Pay Electronically

Use *e-file for Business* to file your business clients' returns and use the EFTPS (Electronic Federal Tax Payment System) to pay all business taxes electronically. With EFTPS you can use the phone, PC software and the Internet (September, 2001).

You receive the same benefits from EFTPS as with *e-file for Business*—speed, accuracy, security, and proof of all transactions, *plus payment history*.

To use EFTPS, you can use the free Batch Filer software for transmitting multiple payments at the same time. You can also use the automated voice response phone system or the Internet to make client payments one at a time. Your clients must be enrolled in EFTPS in order for you to make payments on their behalf.
